

MPSF – Kids Network Permission Statements

Below are the permission statements agreed upon when registering for the Kids Network program.

I understand that the Millard Public Schools Foundation Kids Network program provides care only for children who are toilet trained, have age-appropriate eating, dressing, hygiene skills, and are able to abide by the rules of the program as outlined in the Family Policy Manual, and are able to function effectively in a setting with 1 adult to each 15 children. I certify that the above named child meets these standards.

I give permission for my child to participate in school activities, such as study centers, clubs, or provide classroom help.

I give permission for my child to participate in supervised activities, such as field trips away from the site. This includes permission to be transported to and from activities. I understand that I will be notified in advance of activities off the premises.

I agree that care will be provided for my child according the enrollment category indicated above, and I further agree to pay for such care with the auto direct program through EZ-EFT deducted from my account on the first and third Friday of the month. I understand that tuition is based on the annual amount provided on the fee schedule and divided into 18 equal deductions. I also understand that tuition is based on enrollment, not attendance, or the number of days between deductions dates.

For families receiving state child care benefits: I understand it is parent-responsibility to maintain benefits with Nebraska DHHS and should benefits expire or discontinue tuition will be deducted from the financial institution account on file with the Foundation office. I understand charges are relative to the date of expiration or discontinuance and current enrollment category.

I understand that I have access to the current fee schedule located in the Family Resource web portal (kidsnetwork.mpsfoundation.org). I understand that my deduction amount will remain the same if Kids Network is closed due to a holiday or school is not in session.

I understand that consolidation days and snow days will be in addition to my regular deduction amount that occurs on the first and third Friday of the month. I also understand that I will only be billed for consolidation days if I pre-register my child to attend.

I understand the late fee policy and all charges relating to this policy. I understand that all charges incurred as a result of a late pick-up are non-refundable.

I hereby agree to accept full responsibility for fees and tuition for my child to attend the Millard Public Schools Foundation Kids Network program. In the event that the Millard Public Schools Foundation Kids Network receives notification from your financial institution that your tuition

deduction is being returned for any reason a \$35.00 fee will be assessed to your account. If the Millard Public Schools Foundation receives notification that your payment has been returned, a letter will be sent by the Foundation office notifying you of the return. Payment can be made at the Foundation office by the due date specified in the letter, or the amount will be added with the next scheduled deduction.

If a payment is returned, a letter will be sent to the address on file detailing the amount owed and due date of payment. Your child/ren may be suspended from the program as a result of two (2) consecutive missed payments. If three (3) payments are returned during the school year, a certified letter will be sent by the Foundation office notifying you of the return. If payment is not received in full at the Millard Public Schools Foundation office by the due date specified in the letter, your account may be submitted to collections. Children may be immediately removed from the program as a result of three (3) returned payments during a school year. Parents or guardians will be responsible for any collection costs or charges incurred. If a child/ren is/are removed from the program, and the account is paid in full, the child will be eligible for re-enrollment into the Kids Network program provided the school does not have a wait list, and a \$50.00 registration fee per child is submitted. Completion of new registration processes may be required.
