Sites are subject to change based on enrollment, or maintenance work that may need to be done at the school building. Due to floor cleaning at the above summer sites, sites may be relocated for the last few weeks. Information will be given at your summer site once it becomes available.

1. We will follow all local and state guidelines through the department of health and human services, while also following all guidelines related to Covid-19 set forth by state and local officials.
2. Childcare services will be offered, May 26 – August 7, 2020. The program will be closed July 3, 2020 in observance of Independence Day.
3. Hours of operation will be Monday – Friday, 7:00am – 6:00pm.
4. Summer site locations are Ackerman, Aldrich, Cody, Cottonwood, Rohwer, Sandoz, & Upchurch. As stated above if the enrollment numbers do not require use of all locations, we will minimize the number of sites that we open.
5. We will operate within the classrooms of the summer sites in which we plan to open. There will be no more than 15 children per room. Siblings will remain together. Classes will not intermix throughout the day. Children will have the same teachers daily. Our plan is to place two staff members in each classroom. Classroom assignments will be at the discretion of the program.
6. Breakfast, lunch, and afternoon snack will be provided. Children will eat in their designated classroom. For health and safety, we will not allow outside food to be brought into the site. We will work closely with families whose children have dietary needs.
7. Activities will be provided within each classroom that will consist of table games, arts and crafts, STEM and STEAM projects.

8. Outside time will be designated for each classroom. This will allow children to engage in large motor activities.
9. District custodial staff will be available to help keep our buildings clean and safe.
10. Our exclusion policy for sick children and staff will be monitored and followed as outlined in our family and staff policy manual.
11. Care will only be provided to students currently enrolled in the 2019-20 Kids Network program. Due to regulations, preschool children who attend Montclair Kids Network, will not be eligible for this program.
12. We will provide a detailed summer calendar when the registration link is sent out. At this time and due to restrictions, field trips will not be provided. If restrictions are lifted, we may look at adding some throughout the summer. The summer activity fee of \$50.00 per child *will not* be collected.
13. **Families may register or withdrawal throughout the summer. We plan to be as flexible as possible in the event Covid-19 restrictions change. For example, you may be in a situation where you are currently working from home and may not need care until July. As soon as you know care may be needed, we ask that you contact our main office for summer enrollment information. As a courtesy we would appreciate a two-week enrollment or withdrawal notice so we can plan accordingly. If a decision is made to withdrawal at some point during the summer, please request a withdrawal form from your summer site. If you withdrawal your child during the summer, and care is needed again, it would be dependent upon available space.**
14. Summer tuition will be automatically debited from your account through EZ-EFT on the first and third Friday of the month. There will be five summer deductions, May 22, June 5, June 19, July 3, and the final deduction, July 17, 2020. Tuition is based on enrollment category, not attendance or the number of days between deduction dates. Breakfast, lunch, and an afternoon snack are included in the contracted amount. Families have through May 18, 2020 to remove from their summer registration commitment without incurring tuition fees for the first deduction scheduled for May 22, 2020. Withdrawals received after May 18, 2020 require a two-week notice to take effect.
